



KidsFest Adventure Exhibitor Information

- CYP's KidsFest Adventure will run from May 7-17, 2021. Families will visit different sites across the Outer Banks to participate in activities.
- Activities can be set up for the full ten-day period, or can be on specific days during that ten-day period. *Please let us know if you will only be having activities on certain days, so we can include that information on the adventure guide.*
- All children are able to participate in the KidsFest Adventure, regardless of age. However, activities included on the guide should be geared toward young children (ages birth-five, as they would be during a regular KidsFest event).
- Activities can be set-up specifically for the KidsFest Adventure, or can be something specific that families can do on a daily basis at your site.
- Activities can be set-up by staff for children and families to do on their own, or can be guided by a staff member on-site at the business/organization where the activity is taking place.
- Activities included on the adventure guide for the KidsFest Adventure should be provided FREE. We understand that some places currently require an admission fee* in order for families to enter. However, we do ask that the actual activity listed on the adventure guide be free for families/children.
 - *We know that some places regularly require an entry fee for admission. If you choose to discount or waive this fee for families participating in the KidsFest Adventure, please let us know so that we can list your business/organization as a sponsor on the KidsFest Adventure guide. This is not required, but we would love to be able to recognize your generosity if you choose to waive that fee for families participating.*
- Some activities on the adventure guide will be accompanied by an easy question that families can answer after completing their activity (i.e. what are the numbers above the station door, etc.). We want the questions to be simple, but feel that they provide a wonderful educational opportunity as well. By answering these questions, families who submit their adventure guide at the end of the KidsFest Adventure will receive an additional entry for a grand prize.
